**Qualifications/Method of Nomination:** All engineers are eligible for nomination, provided they are members in good standing of their engineering society, are citizens of the United States, and are licensed professional engineers (P.E.) in the State of New Hampshire or Engineers-in-Training (E.I.T). Candidates for the Young Engineer of the Year Award shall be 35 years of age or younger on December 31, 2010.

The nominee should not be informed of being considered for an award. All nominations not selected for an award shall remain anonymous and the candidate shall not be informed of their nomination.

**Eligibility Requirements:**

Engineer of the Year:

1. Member in good standing of his or her engineering society.
2. Citizen of the United States.
3. Licensed professional engineer in the State of New Hampshire or E.I.T.

Young Engineer of the Year:

1. Member in good standing of his or her engineering society.
2. Citizen of the United States.
3. 35 years of age or younger on December 31, 2010.

**Nomination Format:** Applications should be prepared without participation of the nominee in any way. There is no prescribed form to be completed; however, the nomination package must contain the following sections:

- A. Statement of Nomination.
- B. Statements of Recommendation (minimum of 2).
- C. Biographical Information.

- Engineering research and development experience;
- Technical and non-technical papers authored;
- Patents held;
- Service to the profession;
- Service to the community and for the benefit of humankind;

- Unusual assignments;
- The individual and his/her family; and
- Support of, and participation in, unusual or interesting activities
